## Sandy Spring CSA Membership Agreement

- Organic and naturally grown produce is provided weekly by Calvert Farm, see typical harvest schedule.<sup>1</sup>
- Pick-up dates/times: Mondays, Oct 6 through Nov 24, 2008 Sandy Spring, 1-7pm; Rockville, 2-7pm; Kensington 3-7pm
- Total share price for returning members is \$195, for new members, add \$50. We don't take credit cards, checks only.
- Shares come pre-packed in boxes. Shares may be split among two or more people or two or more households. Members bear responsibility for divvying up the share.

**Returning members:** Spring/Summer 2008 members get priority for the Fall CSA. The price is \$195. due Aug 1, 2007. Starting August 2, all shares are on a first come/first serve basis.

**New members:** The full share price of \$245 is due Aug 1, 2008. Receipt of a \$50 deposit puts you on the waiting list for a share in order of receipt of your check. If you become a member, the \$50 is applied to your total. If you don't get a share, then the fee will be reimbursed.

### **All members:**

94% of your share cost goes directly to the farmers. The rest of the cost goes to administration.

All monies are non-reimbursable, unless otherwise noted. If you drop out, you can sell the remaining portion of your share. We can assist by notifying the waiting list, but we are not responsible for finding someone to take over your share.
